

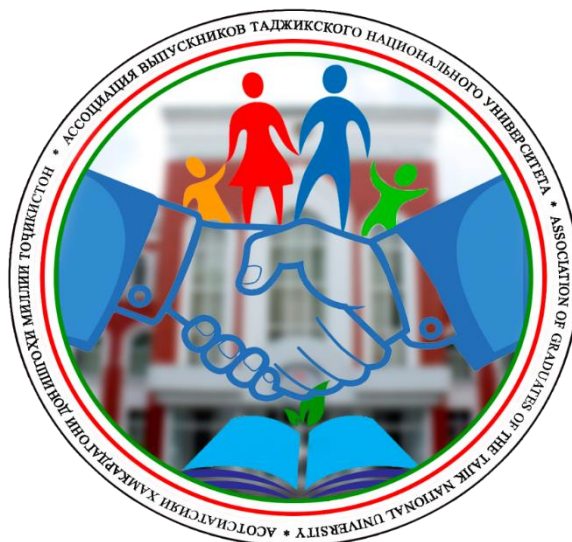

CHARTER

TAJIK NATIONAL UNIVERSITY ALUMNI ASSOCIATION

1. GENERAL PROVISIONS

1.1. The public organization "Association of Graduates of the Tajik National University" (hereinafter referred to as the Association) is a voluntary, self-governing and non-profit association, the goals and objectives of which are implemented in accordance with the Constitution of the Republic of Tajikistan, the Law of the Republic of Tajikistan "On Public Associations", the Charter and other regulatory legal acts.

1.2. The Association carries out its activities independently. The Association has the right to cooperate with local and international associations that have similar goals and objectives.

1.3. The Association is liable for its obligations in cash and property and is responsible for them in accordance with the legislation of the Republic of Tajikistan.

1.4. From the moment of its state registration, the Association is a legal entity, has separate property, fixed and working capital, an independent balance sheet, has bank accounts, owns property and non-property rights, and can also act as a plaintiff and defendant in court, including in economic courts.

1.5. The Association carries out its statutory activities on the territory of the Republic of Tajikistan.

1.6. The governing body of the Association is the guarantor of the implementation of this Charter and is located at the address: Republic of Tajikistan, Dushanbe, Rudaki Avenue, 17.

2. GOALS AND OBJECTIVES

2.1. The main goal of the Association is to promote the diversity and development of the scientific, technical and professional process in the Republic of Tajikistan.

2.2. Objectives of the Association:

1. assistance and resolution of various professional issues in priority areas of development of the national economy, energy, industry, agriculture, management, information, chemical and electronic technologies, pedagogy and scientific and technical spheres;

2. promoting the development of systems of continuous professional education, moral and spiritual education of students, and the formation of their business and professional qualities;

3. strengthening permanent and useful relationships with TNU graduates by involving them in the university's activities, solving current problems of

shaping the worldview of young teachers, and preserving the best traditions of TNU;

4. to promote the expansion of the dissemination of world and regional experience, scientific, technical and technological achievements through the media, information and computer technologies, the publication of newspapers and magazines, textbooks, dissertations, booklets, projects, propaganda, etc.;

5. effective support for graduates of other higher education institutions in ensuring their professional growth and establishing mutually beneficial relationships;

6. support of scientific research activities and theoretical and practical improvement of young scientists of TNU;

7. facilitating the involvement of institutions, companies and other production and infrastructure structures for targeted training of specialists;

8. facilitating the attraction of highly qualified specialists, including from countries near and far abroad, to provide assistance in educational and methodological work at the University;

9. promoting sustainability and strengthening of scientific, technical and cultural cooperation;

10. provision of financial assistance (with the allocation of funds) and implementation of promising programs and projects that contribute to improving the quality of training of specialists;

11. assistance in financing the acquisition of technical equipment, materials and tools for the university, necessary for organizing the educational process and conducting scientific research;

12. assistance in financing foreign trips of interns, postgraduate students and University faculty;

13. facilitating the involvement of the university's scientific and technical resources to address issues of advanced training and participation in research and development work at the enterprise and in various sectors of the national economy;

14. assistance in organizing exhibitions, archives and scientific and technical laboratories;

15. performance of other tasks arising from the activities of the Association.

3. RIGHTS AND RESPONSIBILITIES

3.1. In order to achieve its statutory goals and objectives, the Association has the right, in accordance with the legislation of the Republic of Tajikistan:

- inform the university management and the public about its activities;
- hold meetings, round tables, seminars and conferences, represent and protect the rights and interests of its members in judicial bodies, conclude various agreements with public associations on the territory of the Republic and beyond;
- implement other measures in accordance with the legislation of the Republic of Tajikistan.

3.2. The Association has the following obligations:

- in the process of implementing statutory activities, observe and fulfill the requirements of the Constitution, laws of the Republic of Tajikistan, international legal acts recognized by Tajikistan;
- provide representatives of registration authorities with access to information about the activities of the Association;
- inform registration authorities about various events;
- once a year provide the registering authority with information on the continuation of its activities, indicating the official address of the governing body of the Association.

4. CONDITIONS FOR ACQUISITION AND LOSS OF THE RIGHT TO MEMBERSHIP IN THE ASSOCIATION

4.1. Members of the Association may be citizens of the Republic of Tajikistan, foreign citizens and stateless persons who have reached the age of 22.

4.2. Acquisition of the right to membership is carried out regardless of gender, race and religion.

4.3. Citizens are accepted into Association on the basis of their personal application.

4.4. The right to membership in the Association shall be terminated by decision of the Board of the Association and by a personal application by members of the Association to voluntarily withdraw from membership.

4.5. A member of the Association has the right to withdraw from the Association at their own discretion after the end of the financial year. In this case, they will bear additional liability for the Association's obligations for two years following their expulsion, proportionate to their membership fees.

4.6. With the consent of a member, a new member may join the Association. A new member's admission to the Association may be subject to additional liability for the Association's obligations that arose prior to their admission.

4.7. Members of the Association have the right to:

- elect the governing body of the Association and be elected to it;
- constantly and actively participate in the activities of the Association;
- make proposals to the Association's bodies on issues related to its activities;

4.7. Duties of members:

- carry out its activities in accordance with the legislation of the Republic of Tajikistan and the Charter of the Association;
- implement decisions of the governing bodies of the Association;
- refrain from committing actions that cause harm to the Association.

5. STRUCTURAL UNITS

5.1. To achieve its goals and implement its decisions, the Association opens branches and representative offices in all areas of its activities.

5.2. Branches and representative offices of the Association:

- cannot act as a legal entity;
- does not have the right of ownership to the property transferred to him.

5.3. The structural divisions of the Association, without having the status of a legal entity, carry out their activities on the basis of the Regulation;

5.4. Branches and representative offices of the Association in cities and districts of the republic are not created.

6. MANAGEMENT BODIES AND CONTROL AND INVESTIGATIVE BODIES

6.1. The highest governing body of the Association is the conference.

6.2. The conference is held at least once a year with the participation of at least 3/2 of the members.

6.3. Competence of the Conference:

- adoption of the Association Charter and amendments and additions thereto;
- hearing reports from the Association's board and the investigation commission;
- hearings of the Board of the Association (governing body);
- election of the Chairman of the Association and his deputies;
- election of the chairman and members of the investigative commission;
- adoption of the Association's Program of Activities;
- approval of programs and projects;
- consideration of the issue of dissolution of the Association;

- exercise of other powers arising from the activities of the Association.

6.4. The supervisory and investigative body for the activities of the Association is the Investigative Committee.

6.5. The governing body of the Association during the period between conferences is the Board of the Association.

7. PROFITABLE ACTIVITIES OF THE ASSOCIATION

7.1. To achieve its statutory goals, the association may engage in entrepreneurial activities.

7.2. Entrepreneurial activities are carried out in accordance with the requirements of the legislation of the Republic of Tajikistan.

7.3. Income from business activities is not distributed among the members of the Association, but is used only to achieve the statutory goals.

7.4. Entrepreneurial activities without legal entity rights are carried out by the Association's business entities. In this case, the Association develops and approves regulations for business entities. Business entities have the right to use bank accounts and other accounts.

7.5. Income received from the activities of business entities is used for the purposes and objectives provided for in the Charter.

8. SOURCES OF COLLECTION OF FUNDS AND PROPERTY

8.1. The source of creation of the Association's property is the collected funds.

8.2. Income is generated through entrepreneurial activities, fairs, exhibitions, and the Association's leased property.

8.3. Through the implementation of projects, agreements, contracts, etc.

9. PROCEDURE FOR MAKING AMENDMENTS AND ADDITIONS TO THE CHARTER

9.1. Changes and additions to The Charter of the Association is amended on the basis of a decision of the conference.

9.2. The Charter with amendments and additions will be re-registered with the Ministry of Justice of the Republic of Tajikistan.

10. PROCEDURE FOR REORGANIZATION AND TERMINATION OF THE ASSOCIATION

10.1. The Association's activities shall be terminated in the following cases:

- Reorganization is carried out by decision of the conference, subject to the approval of 2/3 of the votes of the members of the total number of members.

- Liquidation is carried out by decision of the conference with a vote of 2/3 of the members.

10.2. The property confiscated by the Association, after the debts have been paid off, shall be used for the purposes provided for in this Charter.

10.3. The liquidation process is underway by the liquidation commission appointed by the conference.
